Hardship Scheme

If such cases come to the attention of the pastoral team we may be able to assist through our Hardship Scheme.



Unlocking Masonic mysteries

Forty-four people attended our evening event at the Orchid Hotel to listen to our guest speaker Malcolm Williamson. Malcolm is a retired solicitor and a Past Master of Royal Alfred Lodge No. 777 – one of Guildford's oldest Freemason Lodges (warranted in 1859). He provided a short, biographical account of his involvement with Freemasonry over fifty years, which was followed by a lively Q&A session.

One of the sticking points, for a humanist audience, is Freemasonry's insistence that members have to confess belief in a deity. Malcolm explained that the Freemasons do not insist on a specific definition of what this belief means. The way he explained it, it sounded similar to the eighteenth century concept of deism (God as a remote architect) or possibly Spinoza's pantheism: God as a synonym for the totality of the universe. Perhaps its main purpose is to symbolise belief in some kind of universal moral order. Malcolm rejected the idea that Freemasonry is a religion, preferring to describe it as a charitable organisation, but clearly it does have some non-negotiable religious and

ritualistic elements. It is also segregated by sex – a feature which does not endear it to humanists – although there do appear to be some mixed-sex Lodges. Malcolm pushed back against questions which implied that Freemasonry is self-serving and nepotistic, providing examples of how contacts can have socially benign effects. He also said they collect a lot of money for charity. The latest published accounts show that about half of their donations are to Masonic members and dependants, and the remainder of some £12m annually are general grants to worthy causes. In the bar afterwards, we learnt about the secret handshake but we cannot possibly divulge this information! Nichiren Daishonin Buddhism

I was introduced to Buddhism in the late 1970s when I lived in Brockenhurst in the New Forest. I was in my mid 20s and struggling with career options having travelled extensively in Europe and Israel, and then embarking on an overland journey from Istanbul through Turkey, Iran, Afghanistan, Pakistan, and India, finishing up living on a houseboat in Kashmir for quite some time.

On my return home, following several years of travel, I had enormous cultural questions and found myself agonising over the very meaning of life and just how and where I might fit in to this crazy human circus. Fortunately, one of my friends took me to a Buddhist meeting and introduced me to this ancient Japanese practice. I say practice, as I was told that it is not a religion but a practice where ritualistic chanting evokes the mystic laws of cause and effect which in turn can lead to clarity, peace, wisdom, courage, compassion, a sense of empowerment and inner calmness.

Nichiren Daishonin was a 13th century Buddhist priest who sourced the basic doctrine from the Lotus Sutra, claiming that sentient beings possess an internal Buddha nature capable of attaining Buddhahood in the current life. There are three essential aspects to the practice:

- Faith in Nichiren's Gohonson (a sacred scroll inscribed with Chinese and Sanskrit characters and symbols)
- Repetitive chanting of the phrase "Nam Myoho Renge Kyo"
- 3. Regular study of Nichiren's scriptural writing called the Gosho

When I entered the room, I was confronted by a pleasant fragrance and a lot of folk kneeling on small cushions, their backs upright and

hands together in front of them clasping small prayer books and prayer beads. They all faced towards a small shrine with burning incense, a small bell, a few flowers and trinkets and a wooden box mounted on the wall with its doors open revealing an ancient scroll. They were all intently chanting 'Nam Myoho Renge Kyo' over and over again. We quietly joined the back of the room and joined in with the chanting.

It was mesmerising and powerful and the fact that you participated on the same level as everyone else seemed very liberating. I soon adjusted my life to incorporate morning and evening chanting sessions and started to attend group meetings where we would chant and learn the teachings. If you chanted frequently and attended meetings regularly you could eventually obtain a Gohonson (a copy of the ancient scroll) and proudly mount it in your Butsudan (a box which you would mount on the wall) and open to reveal your Gohonson when you were chanting.

The whole thing was quite fantastic, and I soon found meaning and a certain level of clarity in my life. I think I might still be practicing Buddhism if I had not found the daily practice quite so time consuming. Once I got into regular work, I found it very difficult to maintain the practice and felt that I was not doing it justice, so consequently gradually phased myself out. However, I will always be grateful.

If I was not a Humanist, I think I would be a Buddhist and even now would love to attend a group once again and experience the sheer joy of chanting, reminding myself that it is an enlightening practice and not a religion.

It's your column...

From Roger Smith about Israel-Gaza

Regarding your "View from the Chair" last month, my wife Gill and I spent ten days in Poland in September, where we learned all about the Jewish uprising in Warsaw in 1944, its brutal suppression, and the suffering of the Jews under German occupation during the war. The worst excesses of the Holocaust were perpetrated on the Jews in Poland primarily and we had a one day visit to Auschwitz and Birkenau. It was of course a reminder of the terrible atrocities perpetrated against all Jews. Of course one feels overwhelming sorrow and deep empathy for the Jews.

BUT ... (and here I take off my humanist hat and put on my political one) I feel obliged to point out that the "centuries of vicious persecution, culminating in the Holocaust", to which you refer, were perpetrated on the Jews, not by the Palestinians or more widely by the Arab nations as a whole, but by the countries of western, and Christian, civilisation. After the war the victorious countries of that war agreed to the setting up of a Jewish state. Why? By what right? To salve their collective conscience of centuries? To right a long term injustice? The Palestinians and the Arabs never consented to this for the simple reason that to set up a Jewish state requires the existing population to vacate the land of their forefathers. That is wrong and the fact that it was agreed to by the United Nations does not make it right. Sometimes countries get things wrong and make mistakes. Here is a case of the UN getting it wrong and making a mistake.

The problem now is, that, like it or like it not, the state of Israel does exist, and we have to get to an arrangement that all states in the region can support, one that is agreed by the UN as a whole and one that no security council member, be it the US or any other superpower, can veto. That is a big ask.

It is not that we do not feel empathy for the Jews or the Palestinians. They are not conflicting empathies. But empathy alone does not cut the mustard. Action does.

Condemning terrorist action gets us nowhere. When armed militias conduct acts of terror, it attracts widespread condemnation. When states do the same thing, it is justified as self defence. Double standards?

You say "Humanity needs to be balanced with Justice". What does Justice need to be balanced with? "What is Justice?" was perhaps the most enduring of the many questions Socrates first posed. It is much easier to answer the question what is injustice, but it is a question that nobody cares to ask. Why? Because the answer may well prove unacceptable.

Let me conclude. I think a long term injustice has been dealt the Palestinians and until this is recognised as the underlying problem, no solution will materialise.

From Graham Marshall about critical thinking and pseudoscience

Thank you for your outstanding efforts to promote critical thinking. It has been fascinating to continue to study human gullibility during lockdown — a study triggered by links posted by followers on a particular Facebook page. I used to post scientific facts there but was banned from the site! However there are ways and means of seeing the posts still! They stimulate much further study!

My biggest observation is that the followers of the site show total lack of basic scientific knowledge and yet an unlimited appetite to believe in paranormal weirdness. \triangleright

They seem to not just want to believe but seem to actually NEED to believe in a separate world of pseudoscience.

Even Congress is being asked to pass laws forcing Department of Defense disclosure of more than twelve crashed alien space craft including their dead pilots! I so want that one to be true! It would be the biggest story of all history – but it seems to be all hearsay amongst the believer communities who are now to be found in Congress and the Department of Defense. Not a shred of hard evidence is in the public domain. Hence the conspiracy theories.

The biggest recent development is testimony by David Grusch who is now retired from a top secret post as a preparer of briefs for the President. For example, see this report on YouTube. All the pictures of "craft" shown there are fully explained by technically-expert non-believers (please Google "Mick West" who is a British-American science writer and sceptical investigator). No mainstream newspaper has taken the story yet. Believers say that the CIA etc. controllers told them not to! There are now over five billion high definition cameras in people's pockets but no flying saucer pictures of the quality anyone might take at an airshow.

But the Earth is a late arrival on the cosmic stage and there could be civilisations which have studied, and then engineered, physics for a billion years. Only 200 years were needed to go from horses to self-driving electric cars.

There are indeed some compelling witness accounts (for example, YouTube videos of journalist Ross Coulthart and James Fox, director of "The Phenomenon"). They may just represent the drop of beer in a glass full of froth. Perhaps.

So I think the subject is still worth keeping an eye on now and then, but can we really take seriously reports of craft which are advanced enough to travel millions of miles to get here and yet, when do, they crash twelve times?

View from the Chair

any thanks to Roger Smith for responding to my *View* last month about the current Israel-Gaza war (see letters page). Roger and I have continued the discussion with an interesting and educational exchange of emails. Here's my response to four of his points:

- 1. "After the war the victorious countries of that war agreed to the setting up of a Jewish state." I think this gives a misleading impression. The proposal to partition Palestine and create the State of Israel was made through a formal resolution of the United Nations, General Assembly Resolution 181, also known as the UN Partition Plan for Palestine. 33 countries voted in favour of the resolution including the United States and the Soviet Union. 13 countries voted against the resolution, primarily Arab and Muslim-majority countries. 10 countries abstained from voting, including the UK and China. The resolution was adopted with a two-thirds majority, which was required for it to pass. In democratic terms, this was a decisive mandate and the State of Israel was declared the following year on 14th May 1948. And the alternative to democracy is...?
- 2. "The Palestinians and the Arabs never consented to this for the simple reason that to set up a Jewish state requires the existing population to vacate the land of their forefathers." The UN Partition Plan did not require population transfers. It divided the territory into three major parts: A Jewish State, which included regions with a significant Jewish population but also substantial Arab populations; an Arab State, which encompassed regions with a majority Arab population but also included areas with Jewish inhabitants; and an international regime for Jerusalem, encompassing the city and surrounding areas, due to its religious and cultural significance. We do not know how history would have played out had the Arabs accepted the UN Partition Plan but it did not require compulsory population transfers.
- 3. "Condemning terrorist action gets us nowhere. When armed militias conduct acts of terror, it attracts widespread condemnation. When states do the same thing..." Hamas is considered to be a terrorist organisation by the European Union, the US, the UK and other countries. Israel's military actions against Hamas can of course be criticised but it does not "conduct acts of terror". It takes military action to defeat terrorism.
- 4. "A long term injustice has been dealt the Palestinians." This is based on the faulty premise of point (2). The fact that large population transfers did occur in 1948 was a consequence of war which was declared on Israel by its Arab neighbours.

I'm currently preparing a talk for Dorset Humanists on the history of the 1948 war. History itself, even at the highest academic level, can be distorted by ideological and tribal loyalties. A humanist approach is to strive for objectivity and impartiality, however difficult this is. My talk is scheduled for 31st January at the Orchid Hotel.
